

SAID THAT HE DIDN'T KNOW WHAT HE WAS HIT WITH AT FIRST AND BEGAN RUNNING ACROSS THE PARKING LOT TO GET AWAY FROM HIM. 11:05 – Garage door made a load snap as if something was caught in the tracks.



11:06 – Noticed silver car with headlights on 3 houses down. As I passed the car, driver shielded face as if pulling ball cap down. As I drove past the car pulled out going opposite way on the same of the same

Note: After the assault, it later became clear that Alex Cox was in a silver Pontiac Grand Prix and possibly intended to interfere, or block me from arriving for visitation with Tylee. This would indicate that I violated the court order, and ex-wife could immediately file for motion to suspend visitation.

11:09 – Proceeded to High Meadow Dr. (opposite of original exit), in what was possibly an unintended, yet invasive move to loose Alex who probably proceeded on normal direction not realizing my change in direction and timing.

11:30 – Arrived at 8913 Collinfield Dr. for early arrival for visitation. I parked at back of lot next to right side of grass sub-divider near a tree with a picnic bench. Left side of grass divider was SUV of future witness who was in her vehicle with the baby in the back seat.

12:15 Tylee was brought into the meeting room 15 minutes late. Not sure if Lori thought I would not be there, and when confirmed I was there had to show up. Tylee did not appear to be too upset for the 1st visit in over 1 yr. Great visit noted by supervisor.

14:00 – Tylee leaves the room with supervisor and all "visiting" parents must wait 15 minutes for children to clear the premises so no interaction occurs between parents/children post visit.

During this 15 minute wait, I fortunately have a conversation with both future witnesses.

14:15 Leave the Kids Exchange room and walk to parking lot after signing out. Female witness signs out before me, so 2-3 minutes ahead and already out in the parking lot.

14:18 – Alex Cox rises from the picnic table under the tree and approaches me wearing dark ball cap, sunglasses, dark t-shirt, dark vest, and dark pants.

I initially did not recognize Alex and as he approached me:

AC – do you remember me?

- No, who are you?

AC-You don't remember me... I'm Alex.

- what do you want?

AC - We need to talk. As he started to approach me.

to Witness - Can you be a witness?

Witness - Yes, what's wrong?

Alex Cox is my ex-wife's brother – Alex Cox

AC – We are going to talk right now.

We have nothing to talk about.

AC - Yes we do, and this is for what you did to my nephew.

At this point, Alex reaches into either his vest or pants (diagonal type movement with his right hand) and pulls what I thought to be a gun. Alex then lunged toward me with what is now a Tazer and tries to push it into my chest area.

Just before the Tazer can hit me in the heart, I turned my left side of the body and took the 1st hit under or just left of the shoulder blade.

From the initial shock, I raised my arms from the electrical hit, burning, and feeling an intense muscle spasm type sensation.

As I started to run to get away, Alex then had a Tazer 2nd hit in my back with a forceful push that sent me to the asphalt face first. Before hitting the asphalt, I broke my fall with my right hand, and then rolled to my left trying to avoid Alex jumping on me as I was on the ground.

As I rolled to the left, I received

After rolling to the left, I was able to get up and ran diagonally across the parking lot to the main entrance of 8913 Collinfield with Alex steps behind me. As we ran, I am nearly certain he was saying "I am going to kill you!"

As we ran towards the main entrance the 2nd witness, male was leaving the building. I yelled from 40-50 ft away to call 911...call 911. I said "this is Alex Cox and he is trying to kill me."

 2^{nd} witness immediately called 911 and Alex stopped his pursuit from 20 ft from me and the witness. Alex realized the witness had 911 on the phone within seconds.

If 911 has the recording, my voice should be in the background with positive ID of Alex Cox.

Witness was still on the phone as Alex calmly walked away down Collinfield Dr.

Witness and I yelled for Alex to come back; however, Alex just flipped the bird back towards us as he walked forward.

Once the witness and I started to pursue Alex down Collinfield to get an ID on his car, Alex then ran and turned right on Bob White Dr. His car, believed to be a Silver Pontiac Gran Prix was parked approximately 3 house down on the RH of the street.

Alex then ran to his car, and immediately sped away down blue Quail Dr. It was not clear if anyone else was in the car waiting for Alex.


