THE FRONT DOOR OPENED OUTWARD. INSIDE THE RESIDENCE WAS A HALLWAY WHICH LEAD TO A BEDROOM WITH A DESK. THERE WAS ALSO A BATHROOM DOWN THE HALL. ON THE WALL IN THIS AREA WAS A THERMOSTAT WHICH SHOWED THE TEMPERATURE OF THE APARTMENT WAS 74 DEGREES.

THE KITCHEN WAS WEST OF THE FRONT DOOR. A LIVING ROOM AREA WAS WEST OF THE KITCHEN AND THE MASTER BEDROOM WAS NORTHWEST OF THE KITCHEN AREA.

MASTER BEDROOM

THE MASTER BEDROOM WAS LOCATED IN THE NORTHEAST PORTION OF THE APARTMENT. WEST OF THE DOORWAY, IN THE SOUTHWEST CORNER OF THE ROOM, WAS AN OPENED WINDOW. THE SCREEN WAS PROPPED AGAINST THE OUTSIDE BALCONY WALL. INSIDE THE ROOM, NORTH OF THE WINDOW, WAS A BLACK, THIN FAN POSITIONED ON THE FLOOR. NORTH OF THE FAN WERE SETS OF FOLDED SHEETS. NORTH OF THE SHEETS WERE PILLOWS ON THE FLOOR AND AGAINST THE WEST WALL OF THE ROOM. EAST OF THESE PILLOWS WAS A LARGE BED.

ON THE BED WAS THE VICTIM. HE LIE IN A SUPINE POSITION WITH HIS HEAD TOWARD THE NORTH AND HIS FEET TOWARD THE SOUTH. THE RIGHT ARM WAS NATURALLY BENT AT THE ELBOW AND THE HAND WAS UP BY THE HEAD. THE LEFT ARM WAS DOWN TO THE SIDE OF THE BODY. BOTH LEGS WERE SPLAYED. HE WAS WEARING A RED TEE SHIRT AND GRAY UNDERWEAR. THE VICTIM WAS IN ADVANCED STAGES OF DECOMPOSITION WITH BLISTERING, BLOATING AND SKIN SLIPPAGE. THE VICTIM WAS OBVIOUSLY DECEASED.

THERE WERE PILLOWS TO THE WEST OF THE VICTIM. ON ONE PILLOW WAS A TELEVISION REMOTE. EAST OF THE BED WAS A NIGHTSTAND / DRESSER. THERE WAS A LAMP ON TOP OF THE STAND. EAST OF THE STAND, ALONG THE EAST WALL OF THE ROOM, WERE TWO CLOSETS BORDERING AN ENTRANCE INTO THE MASTER BATHROOM. THE MASTER BATHROOM DID NOT CONTAIN ANY ITEMS OF EVIDENTRY VALUE.

SOUTHWEST OF THE BED WAS A BOX WITH A BOOK ON TOP. EAST OF THIS BOX, ALONG THE SOUTH WALL OF THE ROOM WAS A TELEVISION ON A STAND. THE TELEVISION WAS ON.

ON 04/13/2018 AT APPROXIMATELY 1300 HOURS I SPOKE WITH LORI VALLOW, THE EX-WIFE OF JOSEPH RYAN. LORI TOLD ME SHE HAD NOT HEARD FROM JOSEPH IN ABOUT 2 YEARS. THEY DID HAVE A CHILD IN COMMON. I PROVIDED LORI WITH THE POLICE CASE NUMBER, THE OFFICE OF THE MEDICAL EXAMINER'S CASE NUMBER AND TELEPHONE NUMBER. LORI STATED SHE WOULD LET HER DAUGHTER KNOW OF THE DEATH OF HER FATHER.
