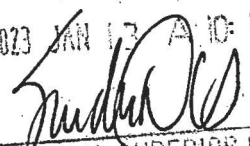

**MOTION TO DENY ACCESS AND MOTION FOR PROTECTIVE ORDER**

COMES NOW the Georgia Department of Human Services acting through the Chatham County Department of Family and Children Services (hereinafter DFCS) and files this Motion to Deny Access and Motion for Protective Order in the above-styled case and shows to the Court the following:

1.

A Subpoena Duces Tecum was issued by the Defendant to "Records Custodian DFCS" on or about January 10, 2023, a copy of which is attached hereto as Exhibit A (with redaction of identifying information of minors).

2.

The subject subpoena requests documents which are confidential and protected under O.C.G.A. § 49-5-40(b), which declares records of child abuse to be confidential and, subject to certain exceptions, prohibits access thereto, as mandated by 42 U.S.C. § 5106a(b)(2)(B)(viii).

3.

DFCS is precluded from releasing any such information without a court order issued following an in camera inspection pursuant to O.C.G.A. § 49-5-41(a)(11). The

documents should not be released unless the Court finds disclosure of the requested information is necessary for resolution of an issue before the Court and is reasonably calculated to lead to the discovery of admissible evidence, as required by O.C.G.A. § 49-5-41(a)(11) and 42 U.S.C. § 5106a(b)(2).

4.

Additionally DFCS is subject to a Protective Order entered by the Juvenile Court of Chatham County on October 18, 2022, a copy of which is attached hereto as Exhibit B (with redaction of identifying information of minors), which further prohibits disclosure of the information identified in the Subpoena Duces Tecum.

WHEREFORE, DFCS requests the following:

- a. The Court perform an in camera inspection of the requested material to determine its confidentiality;
- c. Access to the requested materials be denied to the Defendant; and
- d. Pursuant to O.C.G.A. § 49-5-41(g)(3) the Court issue a protective order to ensure the confidentiality of any released records including prohibiting reproduction and/or redisclosure of said records, requiring the return of said records to the Court and sealing said records upon conclusion of said matter.

Also present were: the paternal grandfather of \_\_\_\_\_, Keith Alan Wharton, and the children's maternal uncle, Michael Simon, were permitted to remain in the courtroom after the hearing was ordered to be closed as persons present to assist a party pursuant to O.C.G.A. 15-11-700 (e). While not parties to this proceeding, or directly subject to this Protective Order, should they violate the terms hereof, the Court may preclude their attendance at future hearings, or consider placing them under a protective order should either of them violate the terms below.

Each of the parties outlined herein consented to the entry of a protective order restraining or otherwise controlling their behaviors and ordering them to abstain from offensive conduct against the children, specifically as to the following:

1. The Parties shall not disclose or share any information regarding the children, their identifying information, their images or likeness, or the same for any sibling(s), or any family member, or other information regarding this case; nor shall any party share or disclose any dependency records or the content thereof; and
2. Social Media: Each Party shall remove, or make wholly private, any and all social media accounts or posts that include information about the children, any sibling(s), family members, or the case, and to refrain from any new social media posts about the children, any sibling(s), family members or the dependency matter.

O.C.G.A. §15-11-29

Counsel requested clarification as to how a party should respond if approached by media or third parties. Either no response, or "no comment", are responses approved by the Court. The parties may fully discuss the matters before this Court with their attorneys.

The parties are hereby placed on notice that failure to comply with this Court's order may be enforced by a citation to show cause for contempt of court by reason of any violation of this order and, where protection of the welfare of the children so requires, by the issuance of a warrant to take the alleged violator into custody and bring him or her before the Court. In addition to all other inherent powers of the Court to enforce its lawful orders, the Court may punish an adult for contempt of court by imprisonment of not more than 20 days or a fine not to exceed \$1,000.00 for willfully disobeying an order of the Court or for obstructing or interfering with the proceedings of the court or the enforcement of its orders.

THEREFORE, IT IS HEREBY ORDERED that the parties to this proceeding, shall comply with all orders of this Court including the above provisions.
