MANGIONE, also known as LUIGI NICHOLAS MANGIONE, did knowingly, intentionally, or recklessly, fail to observe and abide by an officially posted sign authorized by the board or its authorized representative designating a closed area, to wit, a State Parks sign

located at the Nuuanu Pali Lookout, thereby committing the offense of Closing of Areas in

violation of section 13-146-4(a) of the Hawaii Administrative Rules. If LUIGI N. MANGIONE,

also known as LUIGI NICHOLAS MANGIONE is found guilty of this offense, LUIGI N.

MANGIONE, also known as LUIGI NICHOLAS MANGIONE shall be guilty of a petty

misdemeanor and shall be sentenced pursuant to section 184-5 of the Hawaii Revised Statutes.

The following definitions apply to the charge Closing of Areas:

"Authorized representative" means any person authorized by the board of land and natural

resources to act for the board including the chairperson, deputy directors, park administrators,

park superintendents, park managers, and conservation enforcement officers.

"Board" means the board of land and natural resources.

"Premises" means any lands within the state park system.

"State park system" means those public lands or lands under the control and management of the

division of state parks.
