This report is being completed as a supplement to document my involvement in this case, although information gathered by other sources may be referenced for the purpose of context. See other supplement reports for further information.
Background On Monday, February 26, 2024 at approximately 1948 hours, Orange County Sheriff's Office (OCSO) Deputy Sheriff Franky Joseph (10644) responded to the area of the a
Initial Response/Preliminary Investigation The initial responding Deputies made contact with a smother, and leaves s boyfriend, Stephan Sterns who both provided statements.
Stephan stated he dropped off approximately one block away from between 0825 hours and 0840 hours near the intersection of Town Loop Boulevard and Hunters Park Lane. As Stephan was driving away he observed walking in the direction of the school. Stephan then went to a nearby smoke shop to purchase e-cigarette supplies; however, the shop was closed. Stephan then returned to where he waited for approximately one hour before going back to the smoke shop at approximately 1100 hours and staying out to complete some errands. Stephan returned to the home at approximately 1430 hours.
Stephan. At 1600 hours when went to pick up from school, she was informed that add not make it to first period. After checking nearby places sometimes goes after school, according to the places of t
Responding Deputies completed area checks of the surrounding area where was last seen with negative results. Deputies were unable to reach by phone because her phone was left at home that day. Attempts were made to track her OCPS laptop; however, the last pinged location of the laptop car downtown Orlando from Saturday, February 22. Deputies went to the area where Stephan dropped off to look for any evidence. A camera was Jacated at a nearby church located at 13502 Town Loop Boulevard which showed what appeared to be a juvenile being dropped off at the church at approximately 0840 hours by a dark car. The juvenile sits in the parking lot for approximately 15 minutes before walking away. Deputies spoke with an unidentified church employee who stated she remembered seeing a juvenile fitting sits in the parking lot at approximately 0840 hours. A K9 track was completed from that location which did not yield results.
Investigative Detail
As the on call Domestic Crimes Detective, I was notified of this incident. After being briefed of the above information and inquiring further, I determined was not diagnosed with any medical or mental condition which posed a risk to her health or safety, did not make any suicidal statements prior to this incident, and no suspicious circumstances existed at this time. Given the information obtained by responding Deputies during the preliminary investigation, did not appear to be missing under any involuntary circumstances and no suspicious circumstances were articulated at the time of the initial response.
The next morning on Tuesday, February 27, I completed investigative follow up, making contact with states, Stephan, step
I also responded to the church and obtained a copy of the video seen by the Deputies who responded the previous night. In the video, I observed an individual being dropped off in the church parking lot by a dark sedan. The individual gets out of the rear driver's side of the vehicle. After the vehicle drives away, the individual walks out of camera view toward Town Loop Boulevard before walking back into the church parking lot and sitting down for approximately 15 minutes. The individual then gets up and walks toward Town Loop Boulevard out of camera view. Due to the quality of the video, I was unable to positively identify the individual seen in the video as and I was unable to accurately describe the vehicle or the individual's clothing.
After completing interviews, I obtained consent to search search sphone from and a forensic examination was completed on it. I also completed a query of license plate readers which revealed certain inconsistencies in statements collected by Stephan. A review of camera footage in the area where



was allegedly dropped off also revealed inconsistencies. See supplement reports for further detail.
On Tuesday, February 27, 2024; I contacted the Florida Department of Law Enforcement to issue a missing child alert for and broadcasted.
Interviews of
Interview #1: 02/27/2024 at 1116 hours -
stated the last time she saw was on the night of Sunday, February 25, 2024 at approximately 2300 hours inside of the home when she was going to bed. At this time, sent and Stephan up to a guest bedroom. All three were originally going to sleep in stated she needed to get some rest due to her new job making her very tired, she would sleep better alone, and Stephan was going to get ready for school in the morning anyway. Stephan no longer lives in the home with and sand she moved out in December of 2023; however, he has come to visit two or three times since then. When Stephan visits the home, he will sleep in the guest bedroom upstairs while and sleep together downstairs.
The reason Stephan moved out of the home is because he was offered a job by his father; however, the job fell through, and he is trying to move back. Typically when Stephan visits he will stay for a few days; however this time, he planned to stay for a week. Stephan either arrived on Saturday, February 24, or the morning of Sunday, February 25; however, does not remember when.
On the Morning of February 26, 2024; was woken up by Stephan taking their dog for a walk at approximately 0700 or 0800 hours. further explained she did not actually hear getting ready in the morning specifically, as there are also two roommates in the home. fell back asleep shortly after being woken up. At approximately 0900 hours, woke up again and Stephan had not yet returned home after taking to school. left for an appointment at approximately 0930.
Stephan called on the phone at approximately 1018 hours to inform her he just returned home from completing some errands. Stephan informed he originally planned to take to a nearby McDonald's for breakfast; however, did not wish to go, so he took her directly to school. In also informed he attempted to go to a smoke shop to get e-cigarette supplies immediately after dropping off; however, the shop was compared to the home at approximately 1000 hours and spent some time there before going back out to the smoke shop.
returned to the home at approximately 1115 hours. At that time, Stephan had returned to the home. Afterward, waited at home until 1430 hours, at which time, she left to pick up at school. At approximately 1600 hours, waited approximately ten minutes for up to come out; however, she did not come out. It walked there as she sometimes will after school if the was going to pick her up that day, so was informed was not there, and so she then looked for the waste of the wast
reached reached 's friends and teachers to see if anybody saw her at school today, and was informed was absent the whole day. At this point, realized something was amiss and then called 911.
On a typical morning, will take to school no later than 0850 hours. and Stephan have been together on and off for seven years. Thus, Stephan has taken to school in the past, although that responsibility typically belongs to school, Stephan has taken to school one or two times in the past and is familiar with how to do so. When Stephan takes to school, she asks that he does not drive her all the way to school, but rather, prefers to be dropped at a distance from the school so she can walk up. The reason for this is that thinks Stephan's vehicle, a silver 2010 Lincoln MK-Z, is unattractive. Because of this, Stephan agrees to drop near a church located at 13502 Town Loop Boulevard, which is approximately a five minute walk away from the school.
has no history of running away from home or leaving the home when she is angry. does not recall any arguments occurring which may have caused to wish to run away. Sunday, February 25, was so is birthday party, where she had a good time and expressed she was happy. The last time was in trouble was weeks prior to this incident, but does not remember the exact reason why. When went through sphone, she found texts stating when she turned 18 she was going to leave, that was acting crazy, and that was going to send to her father's home. So biological father,

swore to the truth of the statement she provided. This interview was audio recorded.
Interview #2: 02/27/2024 at 2004 hours -
I completed a second interview with for the purpose of clarifying certain information which was collected throughout the course of the day. I presented a still photograph from the video which was captured by the camera of the church at 13502 Town Loop Boulevard and asked her if she was able to recognize the car or in the video. In the video, in the video, in the video, was stated she did not recognize the vehicle; however, the individual seen may possibly have been also re-affirmed her account of earlier events. In the week seen, as the individual does appear to be wearing a light colored top with darker colored bottoms; however, no further identifying features were seen, also re-affirmed her account of earlier events. In the week seen in a text message in her phone. This comment may have stemmed from talking to about the possibility of World War III with the current situation in the Middle East in the weeks prior to this incident.
also re-affirmed that Stephan was, in fact, not home when she woke up at 0900 on February 26. Called Stephan multiple times Stephan returned her call at approximately 1000 hours and informed her he accidentally left his phone at home. The returned home at approximately 1115 hours, at which time, Stephan was at the home as well.
L iew #3: 02/28/2024 at 1502 hours - En Route from Town Place Suite at Flamingo Crossings to the OCSO Central Operations Building
I offered a courtesy ride from the hotel that she and Stephan were staying at to the OCSO Central Operations building. accepted the offer and I transported her in my agency issued vehicle in the passenger seat. During the transport, and I had a brief conversation. While speaking, I noted that referred to using the past-tense several times when she mentioned her. I inquired about whether or not it was normal to allow and Stephan to sleep in the same room unsupervised. replied this was not common practice; however, she did not have any suspicion that anything inappropriate would occur between the two. used to be very hyper vigilant around Stephan; however, as the years have gone by, she has allowed and him to be alone because they get along very well.

Interviews of Stephan Sterns
Interview #1: 02/27/2024 at 1205 hours -
Stephan lives in the home with and and stephan; however, he splits his time between this home and the home of his parents in North Port, Florida. Stephan stated he splits his time due to his parents needing help with their daily care due to being elderly. Stephan arrived at the home this time on Saturday, February 24 or Sunday, February 25.
Stephan stated the last time he saw was on the morning of February 26, 2024 between 0825 and 0840 hours when he was dropping her to school. Stephan dropped a distance away from school at her request so that she could walk with her friends and not be seen in his car, which she finds unattractive. Stephan recalls dropping off along a stretch of road on Town Loop Boulevard near residential communities slightly east of the SR-417 overpass. Stephan described the area specifically as being across from a church, approximately a five or ten minute walk away from off to school in the mornings, because normally does it; however, Stephan was helping on the



morning of this incident due to the needing to sleep.
After Stephan dropped fine and thus was unsure of the exact time he dropped her off. Stephan then went to a nearby smoke shop to purchase supplies for his cigarette; however, the shop was closed. Stephan then returned to the home at approximately 1015 hours and spent time with who had just woken up Stephan then left the home again and went back to the smoke shop at approximately 1100 hours, which was now open. After returning home again, stated she wanted to take a nap, and so Stephan used the opportunity to go out and complete some errands. While out completing errands, Stephan's car suffered a flat tire in the area of US-192 between the hours of 1200 and 1400. Due to the flat tire, Stephan was unable to join from school, as the couple would have had to leave by 1430. By the time Stephan returned home, was already gone.

I asked Stephan which stores he went to when he was out completing errands before he suffer a flat tire between 1200 hours and 1400 hours. Stephan stated he went to a Target and was also in the vicinity of a game shop called house Rules located near the tersection of US-192 and Oak Street in Kissimmee, Florida. Stephan could not provide any other stores he went to. Stephan stated he never went to E. Rules because of the flat tire and he also could not recall exactly where he got the flat tire, and he was only able to describe the area as US-192 in Kissimmee, Florida.
