Favored Nations Agreement It is understood that this is a Favored Nations contract. The value of this

contract, monetary or otherwise, will not be less than the value of any other ANB C-Suite Executive or ANB employee (present or future). No employee receiving funds from ANB, its parent company, and or it subsidiaries, for work performed and or services rendered to ANB by a C-Suite Executive and or an Employee will be receiving more than what is stipulated here. Any superior terms and or conditions, monetary or otherwise, paid out by ANB to a C-Suite Executive and or Employee, must immediately be reflected in an addendum to this contract and given

to Rasta Thomas

Base Annual Compensation \$65,000 Favored Nations minimum starting September 1st.

Compensation not to be less than any other ANB C-Suite Executives and or Employees. Additional annual salary will be provided from Jete Media and Entertainment as determined solely by these companies.

Payment Schedule Bi-weekly each month for 12 months starting September 1st 2017-

August 31st, 2022

Annual Salary Raise A 10% minimum annual salary raise will start September 1st, 2018-2022.

Raise is in addition to any and all favored nations agreement adjustments

Additional Compensation ANB will always use best efforts afforded to it, to give Rasta Thomas

"First Right of Refusal" for any and all work he is qualified for (outside the scope of his primary duties), that ANB is associated with, directly and or indirectly, including but not limited to work with Jeté Media and Entertainment as determined solely by these compnaies. Said work to be

negotiated on a case by case basis

Bonuses Any and all bonuses and or bonus pools paid out to ANB C-Suite

Executives and or its Employees at anytime will be offered to Rasta

Thomas. Said bonuses to be Favored Nations

stipend that covers housing not-to-exceed U.S. Government Basic Housing Allowance (BHA) rates for 003 Officers in South Charleston, South Carolina. Housing allowance will increase to \$1,800 per month on September 1st 2018, \$1,900 per month on September 1st, 2019, \$2,000 per month on September 1st, 2020, \$2,100 per month on September 1st,

2021, and \$2,200 per month on September 1st 2022

Vacations/Time Off In addition to any National Holidays and or breaks, that ANB has off/

celebrates, during a consecutive 10 month period (defined as the season) an additional consecutive 2 months off (defined as off-season) will be given to Rasta Thomas per year. Additional time requests may be

Equipment ANB will give Executive Artistic Director any and all equipment and or

tool required to facilitate and perform all said Roles and Responsibilities

Termination/Buy Out ANB may terminate this contract with Rasta Thomas at any time

providing a full and complete buyout for the entire remaining amount still owed on this contract from the date of termination through August

31st, 2022 is paid to Rasta Thomas

Roles and Responsibilities

Availability

- Must be available during the reasonable business hours of 8:00am 5:00pm Monday through Friday during a consecutive 10 month period (defined as the season). Exceptions may be made for undetermined reasons where these hours and days may change slightly to suit the situation, but will not exceed a 45 hour work week 8:00am 5:00pm Monday through Friday or a 70 hour work week in total for show weeks Monday through Sunday. Overtime rate to be set at no less than \$100 per hour.
- All Artistic and supporting Staff must be available via email or txt at all other times, within reason
- Must attend all Company Performances, Events, and Fundraisers unless otherwise notified
- May be asked to attend Marketing, Photo, Promotional, or Video Shoots for ANB, ANBC

Duties

- Provide artistic vision and leadership to 1st Company, ANB Ambassadors (aka 2nd Company), ANB Conservatory, Support of Community Outreach Programs and Special Projects as directed by the Executive Director within reason
- Execute directives from the Executive Director within reason

AMERICAN NATIONAL

- Available to attend all Board Meetings, Executive Staff Meetings, and Artistic Staff Meetings
- Provide ideas, suggestions, and considerations to the Executive Director and Board of Directors as requested in regards to the following areas:
 - o Potential Productions
 - o Potential Community Outreach ideas
 - o Repertoire and Choreographer suggestions
 - Casting considerations

Daily Duties

- Teach Company, 2nd Company, or Trainee Class as scheduled
- Coach Company and 2nd Company dancers on specific roles or parts of upcoming production
- Rehearse Company, Second Company, or Trainees on choreography for upcoming roles or productions

Other

- Teaching in ANBC Pre-Pro Program 4hrs a week during scheduled class times (must be spread over no more than 2 days, one of which not be Friday and must remain within established 45 hour a week total).
- Maintaining a safe and clean workspace, both in Company Offices and Studios of ANB and ANBC

American National Ballet Conservatory (for-profit)

- Advisor to Board of Directors.
- Will receive appropriate founders shares as determined solely by Board of Directors and CEO.
- Will be compensated for additional work which may be requested.

- Advisor to Board of Directors.
