Since my bank in Dubai did not have a relationship with Fore Group's corporate bank account, which I believe was with Farmington Bank, I was unable to wire the funds for that loan directly to the Fore Group's account. As a result, I caused the \$500,000.00 to be wired from Sweet Partners to Hilliard Farber's account with Bank of New York (the "Wire Transfer"). A true and accurate copy of the wire transfer confirmation is attached hereto as **Exhibit 3**.
- 6. In exchange for and in consideration of the Wire Transfer, Fore Group, Inc. issued me a promissory note dated April 15, 2016 in the amount of \$500,000.00. A true and accurate copy of that promissory note is attached hereto as **Exhibit 4**.
- 7. It is my understanding that Hilliard Farber caused the funds wired to his account to be transferred to Fore Group, Inc.

SIX MONTHS FROM DATE, FOR VALUE RECEIVED, Fore Group, Inc., the undersigned, promises to pay to loannis Toutziaridis, or order, the principal sum of Five Hundred Thousand and 00/100 (\$500,000.00) Dollars with interest thereon at the rate of Four (4%) percent per annum on the unpaid balance of this Note from the date hereof, not in advance, together with all taxes assessed upon said sum against the Holder hereof and together with all costs of collection, including reasonable attorney's fees incurred in attempting with or without suit to collect this Note.

Said principal and interest shall be payable to Holder at, 12 Danais Street, Athens 16671, Greece, or at such other place as the Holder may designate in writing as follows:




