Digital Recording Statement

It should be noted, during this investigation, I was wearing an on-officer body camera and the following is a summary of statements and observations made during the investigation and not direct quotes unless noted. Any breaks or lapse of video is due to either speaking with on scene Officers or an unintentional delayed start of the video. The digital video file was downloaded and stored at evidence.com for further information and details.

Narrative

It should be noted that I was on duty as a Sworn Mesa PD officer wearing my full Mesa PD uniform and operating a fully marked Mesa PD vehicle.

On 01/27/2025 at approximately 2019 hours I responded to [REDACTED] for a missing person call for service. Call comments indicated a juvie AWOL approximately 30 minuets prior.

I spoke with the reporting party who was identified as Cathy Montano with her MVD photo. Cathy is the manager for the group home at the dispatched location.

Cathy indicated one of the clients, [REDACTED] left out of her bedroom window and has not returned. The window's screen was pushed out from the inside. Cathy stated that [REDACTED] has ran away several times in the past. Cathy did not indicate any exigent circumstances. [REDACTED] was described as a 14 year old native female, approximately 4 feet 10 inches, 115 pounds with medium length brown hair. [REDACTED] does not have a cell phone. [REDACTED] was last seen wearing a pink and grey shirt.

Cathy indicated last time [REDACTED] ran away she was located near Fitch Park. My area check was negative at Fitch Park.

Cathy provided a picture of [REDACTED] that was attached to the call for service and submitted to records.

I contacted Mesa Police Records and spoke with records specialist #22199 who assisted with entering [REDACTED] into ACIC/NCIC as a missing person.

I contacted Sgt Hutchinson #15340 and updated him with the details of the case.

Please note this is a supplemental narrative and I am not case agent. My involvement is minimal and I have no knowledge of the final outcome of this case. Please see Original narrative for further clarification.

On 02/19/2025 at approximately 2002 hours I responded to a call for service reference an Agency Follow Up. Call comments stated the reporting party was with the Bureau of Indian Affairs. Additional call comments stated the reporting party had a Jane Doe he believed to be a missing Mesa Juvenile. The missing juvenile was said to possibly be [REDACTED]

Upon arrival I contacted Agent Summers from the Bureau of Indian Affairs Homicide Unit. Agent Summers advised [REDACTED] a female, believed to be [REDACTED] were located within the Gila County Indian Reservation. Agent Summers stated [REDACTED] the Missing Juvenile Flyer distributed by the Mesa Police Department. Agent Summers asked me for contact information to the Mesa Police Homicide unit as to share information and aid in the investigation led by Gila County.

I Immediately notified Sergeant Bailey #20540 of the above mentioned, via cellular phone and provided him with Agent Summers contact information. I ended the phone call and advised Agent Summers the Mesa PD Homicide Unit would be contacting him. Agent Summers stated he understood and I cleared.

On 01/28/25 at received this case for further investigation and review for missing 14-year-old female, [REDACTED] DOB: [REDACTED].

At 1012 hours I contacted Lisa at the [REDACTED]. She advised me that [REDACTED] was still missing, and it was unknown where she could be. I asked Lisa about any medical conditions or concerns for [REDACTED] and she stated that [REDACTED] was on medication for mental health and behavioral issues. She also provided me with the contact information for [REDACTED] San Carlos Apache Tribe case manager, Lori Goode. I then contacted Lori, and she confirmed that [REDACTED] had a history of behavioral and mental health concerns. She did not know of any possible locations for [REDACTED] at that time.

On 01/29/25 I received a voicemail from Lisa that she responded to the Rock Teen Center in Mesa, where [REDACTED] had gone in the past, and they had not seen or heard from [REDACTED] since she left the group home. At 1500 hours I reached out to Lisa, and she said [REDACTED] was still missing and there was no new information on her whereabouts. At 1535 hours I sent a missing person bulletin for [REDACTED] to law enforcement statewide and requested a hospital alert to all local hospitals via Mesa PD Communications Center.

On 02/11/25 at 1053 hours I contacted Lisa for any new information regarding [REDACTED]. She told me that the group home received a voicemail on 02/07/25 from an unknown person stating [REDACTED] was with her mother on the San Carlos Reservation according to a Facebook post. Lisa did not have [REDACTED] mother's information. At 1058 hours I called Lori and requested information on [REDACTED] mother regarding the anonymous tip. Lori advised me that she had recently been to [REDACTED] mother's residence and questioned her about the tip. Lori said when she spoke to [REDACTED] mother, Stephanie Dosela, Stephanie told her that [REDACTED] was not at her residence and the Facebook post was an old post. According to Lori Stephanie said she had not heard from [REDACTED] and appeared to be worried about her. Lori stated that she could go back to Stephanie's residence with San Carlos Apache Tribal Police to verify [REDACTED] was not there. Lori also emailed me the San Carlos Apache Police Department report #250128003 and the Order for Authorization and Consent filed with the San Carlos Apache Children's Court.

On 02/20/25 at 0722 hours I called Lori and left a voicemail for her to call me regarding any

new information regarding [REDACTED] whereabouts. At 1120 hours I reached out to Lisa at the group home who told me that the tip she originally said came in on 02/07/25, was actually sent to the group home on 02/02/25 at 1019 hours by an unknown female.

On 02/27/25 I was contacted by Mesa PD Homicide Detective Ingram #13539, who informed me that [REDACTED] was positively identified by Gila County Sheriff's Office as a homicide victim in their jurisdiction. Detective Ingram advised me to have [REDACTED] removed from the missing person database as he was continuing to assist Gila County with their investigation. At 1655 hours I cancelled the missing person bulletin.

[REDACTED] was cleared from NCIC/ACIC as a missing person.

NFI/ Missing Persons case is closed and the investigation for her homicide is ongoing at this time.
