07-22-2015	I went down to MUSC on this date to meet with Dr. Erin Presnell, she is the pathologist that
	performed the autopsy on the victim in this case. The reason I went and spoke with her was due
	to a preliminary report where she stated that the victim was possibly struck by a motor vehicle
	mirror, which was the cause of death. F/Sgt. Moore had already had from my understanding a
	heated conversation with her about this issue. The MAIT team has always had a good working
	relationship with MUSC, so I wanted to see if I could go down there and get some sort of
	clarification. As soon as Dr. Presnell came into the room she began in a negative tone stating
	that I did not have a meeting scheduled and that she was very busy. She stated that she could not
	even begin speaking with me about this case without the coroners consent. I advised her that I
	had spoken with coroner Washington the day before and she basically called me a liar and said
	she would call him right then. When I asked if she wanted me to call from my cell phone, she
	backed off. I asked her why she stated that in the report and her answer was "because he was
	found in the road". She had no evidence other than that for the statement being put in the report.
	She asked why we did not think it was a vehicle strike and I explained to her that we had no
	evidence of this individual being struck by a vehicle. I asked her if someone with a baseball bat
	could do that and she stated "no". When I probed further saying what about someone in a moving
	car, with a bat she stated "well I guess it's possible". She then asked if we found a bat as
	evidence. I could see that this conversation was not going to yield any positive results. As I was
	leaving she stated that the report was preliminary and it was my job to figure out what it was
	struck him not hers.

08-18-2015	I spoke with Coroner Washington today in reference to the final autopsy report issued from
	MUSC. He faxed me a copy of the report and told me that he does not agree with the pathologist
	stating that the victim was struck by a motor vehicle. We discussed the fact that the report states
	the cause of death as blunt head trauma, motor vehicle crash, pedestrian v. vehicle. Then the
	manner of death was undetermined. I would think that the blunt force head trauma would be the
	cause of death and the motor vehicle crash would be the manner the trauma was delivered to
	cause the death. The pathologist also states in the report, that in light of historical information
	along with the autopsy, these conclusions were made. To what historical information she
	possessed, I am unaware. I attempted to speak with Dr. Presnell at an earlier date to go over
	information that had been discovered throughout the investigation and that was ill received. The
	coroner did tell me that the deputy coroner that had gone down to MUSC the morning of the
	autopsy and spoke with the pathologist, she has since been fired from his office. I spoke with
	that deputy coroner Greene and agent Burke, with SLED, as both of them were present at the
	time of the autopsy. Both stated they made no reference to the pathologist about the victim being





On July 8, 2015 at approximately 6:12AM, SLED Crime Scene was requested by Chief Billy Jarrell with the Hampton County Sheriff's Office (HCSO). Chief Jarrell requested Crime Scene to assist in the investigation of a possible homicide in Hampton County. S/A Tallon made contact by phone with Chief Jarrell. Chief Jarrell provided the following information: The victim was located deceased in the middle of the roadway. Originally HCSO had notified the South Carolina Highway Patrol (SCHP) in reference to this being a possible hit and run. After further investigation it was believed that the victim had been shot in the head. S/A Tallon and S/A Brittany Burke responded to the scene.

Victim: Smith, Stephen Nicholas

Scene Address: 6199 Sandy Run Rd., Hampton, SC 29924

HCSO Lead: Inv. Perry Singleton

Victim's vehicle: 2013 yellow in color Chevrolet Aveo

Upon arrival at approximately 8:25AM, it was cloudy with an approximate temperature of 77°F. Chief Jarrell, Inv. Singleton and several other personnel from HCSO were on scene. Coroner Ernie J. Washington and Deputy Coroner Kelly Green were on scene from the Hampton County Coroner's Office (HCCO). Agents arrived and met with Chief Jarrell, who provided the following additional information: EMS and SCHP arrived on scene. SCHP placed orange paint on the roadway. An EMS worker stated that a projectile wound was located on the victim's head. SLED Crime Scene was then requested and SCHP departed the scene. The HCCO moved the victim prior to SLED Crime Scenes arrival.

The scene was documented with digital photography by S/A Burke and S/A Tallon. S/A Tallon documented the scene with notes and a sketch with measurements.

Upon entering the scene, Agents observed that the scene was secured by HCSO personnel and yellow barrier tape. The victim was covered with a sheet. After photographing the area the sheet was removed. Injuries were noted on the victim's left arm, left hand and head. A hole in the skull was located above the victim's right eye. It was still unclear at this time if this hole was caused by a projectile. The victim's right arm was covered in blood and Agents were unable to see any injuries. Agents searched the area for cartridge cases. This search yielded negative results. The victim's hands were bagged. The coroner searched through the victim's clothing. The coroner located a vehicle key in the victim's front left pocket. This key was turned over to HCSO personnel. No other evidence was located at the scene.

#### **Crime Scene Review**

Prior to leaving the scene, Agents discussed their findings and completed a walkthrough with Inv. Perry Singleton and Chief Billy Jarrel. Crime Scene Agents released the scene to HCSO personnel and cleared the scene at approximately 9:18AM.

Crime Scene Agents then responded approximately 3 miles to the victim's vehicle on the side of Bamberg Hwy. Agents arrived at approximately 9:20AM. After receiving a search warrant Agents searched the area and the vehicle. Footwear impressions were observed in the dirt near the driver's door. The responding officer's shoes were compared to these impressions by S/A Burke and found to be consistent. Therefore footwear impressions were not collected. The vehicle was parked off of the roadway. The gas tank door was open and the gas cap was hanging on the side of the vehicle. The vehicle doors were locked. The key located in the victim's pocket was used to open the vehicle. The vehicle was in park. The battery was functional however, the vehicle would not start. The vehicle was searched. The only item of interest located in the vehicle was the victim's wallet. This wallet was collected by Inv. Singleton. No other items were taken from the vehicle.

Prior to leaving the scene, Agents discussed their findings and completed a walkthrough with Inv. Perry Singleton and Chief Billy Jarrel. Crime Scene Agents released the scene to HCSO personnel and cleared the scene at approximately 9:40AM.

Crime Scene Agents then responded to the MUSC in Charleston, SC. to attend the autopsy of Stephen Nicholas Smith. Upon arrival at approximately 11:29AM, the weather was cloudy with an approximate temperature of 92°F. The following items were collected at autopsy:

· One GSR kit collected from Stephen Nicholas Smith

It was determined that the wound in the victim's head was not caused by a fired projectile. The pathologist stated that it appeared the victim was struck by a vehicle. S/A Tallon then contacted Inv. Singleton and advised him that the SCHP would need to be contacted to investigate this incident further. Crime Scene Agents then cleared from autopsy at approximately 1:43PM and transported the evidence to the SLED Forensic Services Laboratory.

On 07/09/2015 at approximately 8:53AM, S/A Burke responded to 300 Mulberry St., Hampton, SC in reference to meeting with 1st. Sgt. Moore with the SCHP. S/A Burke met with 1st. Sgt. DETAILED STATEMENT OF INVESTIGATION: On 07/08/2015 I Det. Singleton received a call at home from Sgt. Smith with the Hampton County Sheriff's Office requesting my assistance on Sandy Run Rd in Crocketville located in Hampton County in reference to a dead body in the highway. I responded and upon my arrival I was met by Cpl. Bridges who informed me that around 4:00am they received a call from 911 to respond to the location in reference to a person laying in the highway. Once there Cpl. Bridges realized that the person laying in the road was deceased. Cpl. Bridges also mentioned that one Ronnie Capers Jr. reported this to 911. I, Det. Singleton, went up to take a look at the body and noticed a slender build white male on the highway with khaki shorts and a white polo shirt. SLED crime scene was called to process the scene. The deceased had on his person (1) cellular phone and a car key. Highway patrol later located the deceased person's vehicle on highway 601N in the county of Hampton. The vehicle was a 2007 yellow Chevy Aveno. A search warrant was obtained for the vehicle in order for SLED to process it, which they did. A wallet was taken from the vehicle by myself and a picture ID (driver's license) of the deceased male was in the wallet. The deceased was identified as Stephen Nicholas Smith. The body was sent to MUSC for an autopsy which revealed no bullet hole in the deceased but there was evidence of a head injury (see autopsy report).

This case has been turned over to highway patrol and is now closed for the Hampton County Sheriff's Office.

# Activities involving Possible Hit & Run Sandy Run Road near Joe Miley Road Stephen N. Smith 1/29/1996

### July 8th, 2015

I was called by Cpl. Allen at 0537hrs advising we had a possible Hit & Run fatality on Sandy Run Road. He was advised to call the on-call commander (Lt. King).

Cpl Allen called me back at 0608hrs to advise the MAIT team was enroute to the scene and he was almost there. I left my residence and headed to the scene and was advised by Cpl. Allen that it was a homicide, not a hit & run. I advised Cpl. Allen to make sure that was the ruling of the coroner and Hampton County Sheriff's Office and that I would be there shortly. I arrived on scene at approximately 0625hrs and observed a white male lying in the roadway on the center line with head trauma to the right side above his brow. I spoke with Hampton County Coroner Ernie Washington, who immediately advised me it was a homicide. He pointed out the wound to be a gunshot wound and showed me the entry point. Assistant Coroner Kelly Greene then began to show me photographs they took, again pointing to the entry point to the head and also a defensive wound to the hand. I then asked for clarity if they were sure it was a homicide and their response was yes. I then advised we no longer needed the MAIT team. I asked if our assistance was needed and I was told no, they were just waiting of SLED's crime scene unit to arrive. I walked the scene and saw no evidence of any car parts or pieces and then had all units clear the scene.

At approximately 1615hrs I was called by L/Cpl. Rowell, who advised the Sheriff T.C. Smalls called him and advised an autopsy was conducted as MUSC and that no bullet was found and it was determined to be a Hit & Run. I immediately called Sheriff Smalls to clarify the issue. He advised me that the Doctor was ruling it a motor vehicle accident and they were turning it over to us. I asked if he was the lead investigator and he advised me Lt. Perry Singleton was the lead investigator and gave me his phone number . I immediately called Lt. Singleton and asked for any notes or information he had and he told me he was not at his desk and would call me back in thirty minutes. I then called Hampton County Coroner Ernie Washington at 1640 hrs and asked him if that was his ruling as well and he stated he would have to go with the Doctor's ruling. I then reminded him that earlier that morning they were certain it was a gunshot wound and he told me he had to go by the opinion of the Doctor. I asked him where the body was at and he stated it had been taken to Rhoden funeral home in Hampton per the family's wishes at the time of the death notification. I asked him what time and who they notified and he stated that they notified the mother and father (Joel and Sandra Smith) at their home at at approximately 1030 hrs. I called the funeral home and spoke with Gordon Rhoden ( I asked him if he had the clothing the deceased was wearing so we could pick it up and he stated it was in a paper bag with the body. I asked him to immediately stop whatever preparations they were making to the body and cover him up and we would come get the clothing. He agreed to do so and I had L/Cpl. Rowell pick up the clothing shortly, I then called Lt. King at 1757 hrs to advise him what was occurring and he told me he would make some calls and get back with me. I immediately called back Ernie Washington and asked for the name and phone number of the Doctor who conducted the autopsy. I was given her number and called a Doctor Aaron Presnell to try and understand what brought her to that decision. She said that it was not a gunshot wound and no bullet or fragments were found during the x-ray and that it didn't look like a bullet wound in her opinion and that since the body was found in the roadway, she could only theorize that it had to

be a motor vehicle that caused the death. I asked if he had any other injuries and she stated only a partial dislocated right shoulder. I asked her if she found any glass fragments or any other evidence of a motor vehicle and she stated no. I than asked her why she was ruling it as a motor vehicle accident and what she thought caused the head injury. She told me it was not her job to figure that out, it was mine. I then tried calling Lt. Singleton back since he had not returned my phone call and all I got was his voicemail. I then hung up and call Sheriff Smalls to see if he could get me the information they had and he stated he would call me right back. After not hearing back from him as well, I called him back and got his voicemail as well. I then called L/Cpl. Rowell to see if he was in Hampton and he advised he was on his way from Bamberg. I told him to go back by the scene and make sure the body had been marked and to start looking to any vehicle debris in both directions. He called back and advised he could find no debris at all. I then called L/Cpl. Altman and told him when he came out to go to the scene at Sandy Run Road near Joe Miley Road and look for any vehicle debris. He also called back stating he could find nothing. I then told him to go out to the scene and sit from around 0300 hrs until 0500 hrs to document what type of traffic was moving that time of the morning. Lt. King then called me back at 1928 hrs and advised Lt. Brock with the MAIT team would be calling me and to see if I could get in touch with someone from SLED to come out the next day. I spoke with Lt. Brock at 1940 hrs and explained the entire scenario to him. He advised me to have someone go out to the scene and look for debris. I told him I already had someone on scene and he advised he would have Sgt. Booker call me shortly. I spoke with Sgt. Booker at 2002 hrs and explained the scenario to him. We decided to meet at the funeral home in Hampton the next day at 9am and asked if SLED could meet us there as well. I told him I would find out which agents were there and try and set it up. I called Agent Jeff Croft with SLED, whom I knew, to see if he could find out which agents came to the scene that morning. He called me back with the name and phone number of Brittany Burke I called her at 2022 hrs and she stated that she and Agent Trey Tallon were called out at 0610 hrs that morning at the request of the Hampton County Sheriff's Office regarding a homicide. She stated they arrived at the scene around 0900 hrs and looked at the wound and didn't think it was a gunshot wound. She stated they told the Sheriff and Coroner that they didn't believe it to be a gunshot wound. She told me they were adamant it was a gunshot wound, so they mapped the scene and began to gather evidence as they would normally do. She stated that they found a smart phone and car keys in the deceased right pocket. The phone was undamaged but could not get it work. They also located the vehicle of the deceased on US 601 a couple miles from the scene and also checked that as well. They went through the vehicle and found the wallet of the deceased and also noticed the gas cap was off. They also found engine oil in the vehicle and believed that he had vehicle trouble because they could not get the vehicle to start. Since he was found between the vehicle and his residence, they believed he was walking home when the incident occurred. She also advised me that they went to the autopsy along with assistant coroner Kelly Greene and the doctor confirmed it was not a gunshot sound, which is what they (SLED) believed originally. At that point, she stated they left and returned to Columbia. I asked her if she could come to the funeral home the next morning at 9am and she stated she would have to ask her superior and call me back. She called back at 2042 hrs and advised she would be there at that time and would bring all her notes and photos. I called Sgt. Booker back at 2045 and advised him that one of the SLED agents would meet us there at 9am.

### July 9th, 2015

I called L/Cpl. Rowell and L/Cpl. Payne at 0550 hrs that morning and told them both to go back out to the scene at Sandy Run Road and look for any debris of any kind or anything out of the ordinary. They called me back and again were unable to find anything and I asked them both to meet me at the Rhoden funeral home at 9am for a meeting. I then spoke with Lt. King at 0835 hrs and briefed him regarding the time and location of the meeting. He advised me to get in touch with CRO Sonny Collins to explain what

was going on before the flyer was sent to him to push out to the media. After leaving a message with him, I had Sgt. Burns call him as I arrived at the funeral home. I meet Sgt. Booker and Cpl. Duncan from the MAIT team at 9am along with SLED agent Brittany Burke at the Rhoden funeral home as well as L/Cpl. Rowell and L/Cpl. Payne. The MAIT team took photos of the deceased and spoke with Agent Burke regarding her finding and reviewed her notes and photos. MAIT also inspected the body of the deceased for any evidence and injuries. There were no visible injuries to the deceased, other than his head wound and a small amount of road rash on both arms. He had no broken bones and no injuries whatsoever on his torso or lower extremities. I turned the clothing over to Cpl. Duncan and after a discussion by all parties as to why this did not to appear to be related to a motor vehicle, I went with the MAIT team along with L/Cpl. Rowell to Ronnie Capers, Jr.'s residence to speak with him. He was not home, but the MAIT team did look over his wrecker sitting on the dirt road in front of his house but didn't find anything that looked suspicious. We then went to the scene on Sandy Run Road and along with MAIT, looked for any evidence at the scene for approximately 100 yards in both directions. Cpl. Duncan and L/Cpl. Rowell left the scene to go speak with the family of the deceased, while I stayed with Sgt. Booker to assist him as he documented the scene. When they returned, they were told by the family their son was gay and that they did not know of any enemies their son had, but anything was possible regarding his death. L/Cpl. Rowell got a call from Lt. Singleton advising they had the phone and wallet of the deceased. L/Cpl. Rowell, Sgt. Booker and I met with him at their substation in Varnville. After a discussion with Lt. Singleton, who stated he thought a log truck may have struck him, gave us what information they had and Sgt. Booker signed for the cell phone. The wallet was left with Lt. Singleton since it had been unsecured since the previous morning and had money in it. He was advised to return it to the Coroner's office. A warrant was obtained in Hampton County for the phones contents and was forwarded to Sgt. Booker to take to SLED to retrieve the information on the phone. Sgt. Booker returned back to Charleston and L/Cpl. Rowell and I began riding the area looking at possible logging sites. They were all old sites that obviously not been used recently. We then went to McMillan Farms on the same road and L/Cpl. Rowell and I spoke with Mr. McMillan who runs the farm. We asked if we could look at his trucks and he agreed. He had a few seed trucks that we looked at, but we did not see any damage or evidence of bodily fluid or blood. After speaking with Mr. McMillan, he advised his trucks weren't running at this particular time since there was no grain to haul. When asked he stated he did not know of any trucks logging in the area, nor did he know of any particular trucks that would be running during the early morning hours. After we left McMillan Farms, L/Cpl. Rowell was advised to ride the area further to look for farming or log trucks and I went to Bobcat landing where the deceased had supposedly hung out the night before swimming. I did not see anyone there or anything out of the ordinary.

### July 14th, 2015

I was contacted by L/Cpl. Rowell who was with Cpl. Duncan in Hampton. They had spoken with family of the deceased and advised he had an ipad and laptop that he was using under at least on alias "Noah Rivers" to go into homosexual chat rooms. They agreed to turn that over to be analyzed and a warrant was obtained for those items to take to SLED. They also interviewed a subject in his 40's who was supposedly the boyfriend of the deceased and believed there was foul play, but his story was inconsistent and was asked to take a polygraph by the MAIT team. He stated he would do so, that has yet to be arranged.



## FAMILY OF STEPHEN SMITH REACTS TO THE INDICTMENT OF ALEX MURDAUGH

Sandy Smith, the mother of Stephen Smith, would like to convey her appreciation to the State Law Enforcement Division [SLED] and South Carolina Attorney General Alan Wilson for their action today in Colleton County regarding the murder indictments of Maggie Murdaugh and Paul Murdaugh.

Earlier today, Alex Murdaugh was indicted in Colleton County for two counts of Murder and two counts of Possession of a Weapon during the Commission of a violent crime in the deaths of his wife and son on June 7, 2021 at their country home, Moselle.

Stephen Smith was found dead on Sandy Run Road in Hampton County, South Carolina on July 8, 2015 under suspicious circumstances. Stephen's death was the first in a string of deaths in Hampton County which have collectively gained worldwide media and public attention. The tragic deaths of Stephen Smith, Gloria Satterfield, Mallory Beach and most recently, Maggie and Paul Murdaugh, have been under intense scrutiny and investigation by journalists, lawyers, private investigators, and law enforcement officers. Despite all of the scrutiny, Stephen Smith's death remains shrouded in mystery and unanswered questions.

On June 23, 2021, SLED spokesperson Tommy Crosby released the following statement: "SLED has opened an investigation into the death of Stephen Smith based upon information gathered during the course of the double murder investigation of Paul and Maggie Murdaugh." However, the Smith family has consistently stated they have no knowledge or reason to believe that any member of the Murdaugh family was involved in Stephen's death.
